## **2006**

The Club elected some new officers for 2006. New were: President Vern Hosier, Vice President Carl Leadingham, and Secretary Emily Jacobs. The club liked these folks so well that they were re-elected for 2007. The Boy Scouts used the Club again this year for their Klondike. A couple of 4H groups used the club facilities. The Club re-affiliated with Michigan United Conservation Clubs. We adopted new bylaws and printed up new handbooks. We discovered that this was the 90<sup>th</sup> year of the Club's existence too late for a proper celebration. But now we know that we have a little over 9 years to prepare for our 100<sup>th</sup> birthday. The club has a new website that will allow us to incorporate paid advertising. And more importantly, does not severely limit the size of files on the site, so that large pictures, or handbooks may be included. This year saw some new things in hunter safety. You can now study for a hunter safety test on the Internet. Our first class had only a handful of students. The second had 45, but only 39 were successful. Testing is much more thorough. The Youth Sportsfest Camp recovered a little from the 2005 rainout. We had over 20 participants. The Annual Banquet continues to grow. For 2007 we think we will have enough turnout to have a varied menu -- not everyone likes prime rib. Some things didn't go so well. Action pistol dropped back to one night per week. We made zero progress on the dirt problem, primarily due to stonewalling by the DEQ. We couldn't find a timber harvester interested in the trees until late in the year. As a consequence, we lost another year of sporting clays. We had trap machine broken spring problems. It might be a warning to start thinking about rebuilding or replacing. Rifle Sight-In day was poorly attended. The 3-gun shoot was not developed this year. We will try again in 2007. The Club picnic was about the same. On the bright side, our favorite legislators, and fellow members, Tonya Schuitmaker and Fulton Sheen were re-elected. Ought six was not a bad year.

## **Fingerprinting bill signed into law**

Sheen bill eliminates needless renewal steps

Legislation to eliminate needless steps in the license renewal process to carry a concealed pistol was signed into law yesterday [December 20], announced the bill's sponsor, state Rep. Fulton Sheen.

Currently, in order to receive a license to carry a concealed pistol (CPL), applicants undergo a thorough background check by providing fingerprints every time they renew a license. Public Act 456 eliminates the requirement to submit a new fingerprint every time a CPL is renewed. Fingerprints will be stored electronically by the Michigan State Police's new Automated Fingerprint Identification System (AFIS), which means that the next time an applicant renews will be the last time that they are required to submit fingerprints.

"I am very pleased we were able to work to put into law this common sense legislation that will use new technology to save time and resources for Michigan citizens as well as law enforcement agents," said Sheen, R-Plainwell. "PA 456 allows law enforcement agencies to fully utilize emerging AFIS technology while still maintaining the same degree of scrutiny, only now more efficiently. This law was requested by the state police, who are working diligently to store all fingerprints digitally."

Sheen said because of the new technology of the AFIS system, MSP can immediately identify when a CPL holder commits a crime due to instant electronic fingerprint comparison. To ensure the safety and reliability of the system, those with a CPL must still reapply for the permit every five years, though under PA 456, they will not have to resubmit fingerprints. MSP will also be able to use the renewal fees to maintain and update their new equipment, rather than pay the cost of physically obtaining the fingerprints.

### **TARGETS**

Ours is a nice club. You may have a key to come out to shoot when the range is free.

However, we ask that the casual shooter bring his own targets, or drop some money in the black box to help pay for ones used.

The silhouette type targets are used for action pistol. They are fairly expensive as targets go. On action pistol night, each shooter pays \$3 to pay for targets. If you use these at other times, please drop \$3 or so in the slot in the box.

[The big target frames on wheels are for archery targets and must not be used for bullets. They cost hundreds of dollars, and are ruined by bullets.]

The larger pieces of cardboard mounted on movable bases are usually barriers and other props used for action pistol. They are not intended to be targets. There are other frames used to mount knock down targets. The bottom line is that everything you find at the club is not a target. If you don't know the purpose of something, please don't shoot it.

Some time ago a member brought out a lot of cardboard squares for use as targets. They are white and can be marked with felt pens or have paste-on targets stuck upon them. Hang them on the rope at the back of the range and shoot them. That is what they are there for.

## **THERMOSTATS**

There is always someone who does not like the temperature. This is human nature and the cause of thermostat wars. At the club, we have installed an automatic thermostat to protect the facility from these people. The thermostat reverts back to pre-set level after a few hours. Feel free to turn the thermostat up if you find the range too cool. However, if you are shooting, and have the fans on, please do not do this. The furnace can't heat the whole township.

Do not understand thermostats? Please turn up the thermostat only to the temperature you would like. A furnace is an on/off device. Turning the thermostat up to 100 degrees, or more, will not heat the area any faster.

Finally, do not turn the thermostat off. If you have to ask why, turn in your key.
