## **BATF INSPECTION**

We have been advised by the Bureau of Alcohol, Tobacco, and Firearms that we will be receiving a compliance inspection soon. We had one of these a few years ago. As I recall it was no big deal. I can't imagine too many gun clubs involved in illegal gun running. Perhaps things are slow at the BATF.

## **TRAP MACHINE**

Apparently our trap machine is in need of repair, maintenance, a good cleaning, or all three. We had a offer some time ago from someone who would refurbish our machine. We may need to investigate this if there are no members who can tackle the job, and have the time to do so.

An alternative is to consider a new machine. The last I checked, a new Promatic would cost about \$2300. Since trap is one of the few shooting activities that brings significant amount of revenue, perhaps we ought to invest some money to keep it that way.

A third alternative is to return to the use of the old Winchester machine, and manually load birds. Though, I don't think many would want to hand set birds in the winter time.

## **MUCC**

It seems we had a bit of a mix up on our way to re-affiliating with Michigan United Conservation Clubs (MUCC). We didn't get our paper work in, and so our joining is a tad late. This has been rectified and I believe the check actually is "in the mail."

Dick Kriner is our MUCC representative. He is in the sunny south right now, but we anticipate having this all ironed out by the time he gets back. I hope so. Otherwise he may have to "take us to task." I'm not sure what that means, but I'll bet it isn't a trip to the Dairy Queen for ice cream.

## **DEALS THAT AREN'T**

Bass Pro Shops Online had a deal that appeared to be made for rod & gun clubs. All we had to do is put a link to Bass Pro on our web site. Then when anyone visiting our web site linked to them, we would receive a commission if they bought anything. After some investigation, it turns out there is a "middle man" called Commission Junction (CJ). In the fine print, it appears that CJ expects to make money all the time. If we haven't generated enough sales to meet CJ's requirements, they will charge us an unspecified amount (and compound it at 1.5% interest) until we either pay them or have enough sales through our web site link to pay off this unknown amount.

I questioned the folks at Bass Pro about this, and they referred my question to CJ. The deafening silence so far tells me I am reading it right. Signing up for this deal is essentially giving CJ a blank check.
