I, the undersigned, Releaser, being of lawful age, in consideration of being permitted to participate in the shooting sports at the South Haven Rod & Gun Club., do for myself, my spouse, legal representatives, heirs, and assigns, hereby release, waive and forever discharge the South Haven Rod & Gun Club, its agencies or departments, its officers, agents, service members and employees in their official and personal capacities, their heirs, administrators and executors, from any and all liability for any and all loss or damage, and from any and every claim, demand, action or right of action, of whatever kind of nature, either in law or equity, arising from or by reason or death, or any bodily injury or personal injuries known or unknown, or property damage resulting or to result from any incident which may occur during my participation in the South Haven Rod & Gun Club or any activities in connection with the South Haven Rod & Gun Club, whether caused in whole or in part by the Releasee's or otherwise.

MY COMMITMENT TO SAFE GUN HANDLING

Anyone who uses a firearm has a responsibility to themselves and others to use the firearm safely.

- ALWAYS KEEP YOUR FIREARM POINTED IN A SAFE DIRECTION.
- TREAT ALL FIREARMS AS IF THEY ARE LOADED.
- KEEP YOUR TRIGGER FINGER OUTSIDE THE TRIGGER GUARD AND OFF THE TRIGGER UNTIL YOU ARE READY TO FIRE.
- BE CERTAIN OF YOUR TARGET, YOUR LINE OF FIRE, AND WHAT LIES BEYOND YOUR TARGET.
- ALWAYS KEEP YOUR FIREARM POINTED DOWN RANGE.
- ALWAYS WEAR APPROPRIATE EYE AND HEARING PROTECTION.

I acknowledge that I am familiar with the basic rules of firearm safety. I agree to follow all the basic rules of firearm safety at all times during my use and handling of any firearms in addition to the SHRGC rules and individual range rules

Anyone who violates Range Safety / Range Rules or acts with disregard for fellow members, club officers, or visitors will be denied access to the SHRGC or property.
