Anyone who uses a firearm has a responsibility to themselves and others to use the firearm safely.

- ALWAYS KEEP YOUR FIREARM POINTED IN A SAFE DIRECTION.
- TREAT ALL FIREARMS AS IF THEY ARE LOADED.
- KEEP YOUR TRIGGER FINGER OUTSIDE THE TRIGGER GUARD AND OFF THE TRIGGER UNTIL YOU ARE READY TO FIRE.
- BE CERTAIN OF YOUR TARGET, YOUR LINE OF FIRE, AND WHAT LIES BEYOND YOUR TARGET.
- ALWAYS KEEP YOUR FIREARM POINTED DOWN RANGE.
- ALWAYS WEAR APPROPRIATE EYE AND HEARING PROTECTION.

I acknowledge that I am familiar with the basic rules of firearm safety. I agree to follow all the basic rules of firearm safety at all times during my use and handling of any firearms in addition to the SHRGC rules and individual range rules
